## **HOW TO OBTAIN NEW IDENTIFICATION**

### **TO GET A NEW BIRTH CERTIFICATE:**

- ◆ Contact the Department of Health in the State where you were born.
- ◆ If you were born in Tennessee-  
A certified copy of the court order; original birth certificate and a check or money order for \$30.00 should be sent to: TN Vital Records, 710 James Robertson Parkway, Nashville, TN 37243
- ◆ It usually takes 3-4 weeks to receive your new birth certificate.
- ◆ If you wish to speak with someone, call (615) 741-1763 Amendment Unit.

### **TO GET A NEW SOCIAL SECURITY CARD:**

- ◆ Go to any local Social Security office
- ◆ Call (800) 772-1213 to request an application, you should receive it in the mail within 2 weeks.
- ◆ The web address is [www.socialsecurity.gov](http://www.socialsecurity.gov).
- ◆ There is no charge for a new social security card.

### **TO GET A NEW DRIVERS LICENSE:**

- ◆ Take a certified copy of the court order to the testing center located at 1120 Tyson Ave. Paris, TN 38242
- ◆ The hours of operation are Monday-Friday 8:30am – 5:00 p.m.
- ◆ There is a charge.
