- Contact the Department of Health in the State where you were born.
- ♦ If you were born in Tennessee-A certified copy of the court order; original birth certificate and a check or money order for \$30.00 should be sent to: TN Vital Records, 710 James Robertson Parkway, Nashville, TN 37243
- ♦ It usually takes 3-4 weeks to receive your new birth certificate.
- If you wish to expedite this request, there is an additional \$5.00 fee.
- ♦ If you wish to speak with someone, call (615) 741-1763 Amendment Unit.

TO GET A NEW SOCIAL SECURITY CARD:

- ♦ Go to any local Social Security office
- ◆ Call (800) 772-1213 to request an application, you should receive it in the mail within 2 weeks.
